Bruce J. Berno Nominated by Greater Cincinnati Foundation

Steve Black Nominated by CET

CET's mission is to strengthen the communities it serves through programs and services that inspire and inform, educate and engage, fostering citizenship and culture, the joy of learning and the power of diverse perspectives.

Michael Hirschfeld, a past chair of then-WCET's Board of Trustees, best summaries the special and remarkable qualities that his colleague and friend, Steve Black, offers the community. "As a past CET board member and law partner of Steve's, I can think of no one more deserving of this recognition. In addition to his other civic and charitable activities, Steve's passion for and dedication to public broadcasting and its mission was reflected regularly in his role as a long-term member and chair of the CET Board. Steve comes from a family with a history of deep involvement and impact in our community, and he has carried on that tradition."

CET is honored to work with Steve, who joined the CET and Think^{TV} Board of Trustees in 2011. As chair, he led the board for two terms, from 2017 to 2019, during a pivotal time in our ever-changing world of television broadcast technology.

As a fourth-generation Cincinnatian attorney, Steve earned a bachelor's degree in economics from Harvard College and a law degree from Harvard Law School. At the beginning of his career, he served as a clerk to a federal appeals court judge before moving to the well-known firm of Graydon, Head, and Ritchey, LLP. After nearly four decades of practice in areas that included commercial litigation and estate planning, Steve retired from the active practice of law in 2013.

CET recognizes Steve's humble dedication and perseverance to ensure that a deceased donor's wishes come to fruition as the donor intended. When there were alarming and unexplained delays in the administration of a charitable trust, Steve took it upon himself to assist CET as needed. When the station needed assistance with another donor's out-of-state estate, Steve was the bridge for a resolution between the station and the attorney handling the probate case.

A loyal and generous supporter of public television, Steve currently also gives of his time to a state-appointed position on the board of the Ohio Broadcast Education Media Commission. Locally, Steve holds board positions on the Ohio Innocence Project as well as the Children's Home of Cincinnati Foundation. He has also previously served on several other community and governmental boards throughout the region.

Today, you will find Steve raising Belted Galloway cattle on his small, family farm north of Cincinnati. He also enjoys time with his wife, Susan, a retired psychiatric social worker, their three adult children, and three young grandchildren.

As a 1962 graduate of The Christ Hospital School of Nursing, Joyce began her nursing career at The Christ Hospital, where she served as a Staff RN, Head Nurse, Nursing Director, and Assistant Vice President of Nursing.

She obtained her Master of Education from Xavier University in 1984, and in 1991, she became Vice President of Clinical Services at Middletown Regional Hospital. She was recruited by Hospice of Dayton to lead them in gaining their first Joint Commission Accreditation and served there as Vice President for Clinical Services and Quality Improvement until her retirement in 2007.

In 2015, Joyce joined The Christ Hospital Foundation Board and gives generously of her time and resources to help raise funds and advocate for the hospital and The Christ College of Nursing and Health Sciences. Joyce has generously included a bequest in her estate plans to support nursing scholarships. As a planned giving donor, she shares her story and encourages others to include the College in their estate plans as a way to leave a lasting legacy of support for future students pursuing the nursing profession.

Joyce has been instrumental in making a Christ College of Nursing education accessible to the most deserving nursing students. Even after a house fire destroyed her own home and virtually all her possessions, followed by the death of her husband, Joyce continues to devote a portion of her life to her own special version of "Paying it Forward." The Christ Hospital Foundation is grateful for Joyce's continued partnership and unwavering commitment.

Last year, Joyce published her first children's book, *Daisy's Adventure*. Half of proceeds from all book sales support the College's Nursing scholarship fund and Joyce's dream of supporting the next generation of nurses.

Linda Greenberg Nominated by Cincinnati Playhouse in the Park

Cincinnati Playhouse in the Park is a professional, regional theatre committed to producing and presenting for diverse audiences the broadest range of theatre in an inviting theatrical environment. Their mission is accomplished through works of the highest caliber produced onstage in a fiscally responsible manner, and through stimulating education and outreach programs.

Linda fell in love with the magic of live theatre after her mother took her and her sister to see The Fantasticks in 1966. "I still recall how magical it was in that small theater," she says, "with actors performing so close to the audience and the connection we all felt as a community." Linda has been a fan ever since. Today, Linda and her husband, Gary, have been Cincinnati Playhouse in the Park subscribers since 1978 – 42 years! During this incredible time, she has played a key role in shaping the Playhouse into what it is today.

Linda and Gary regularly participate in the Playhouse's programs and events, and along with their children have made many incredible memories with their family at the Playhouse. Not only does she bring her leadership to the Playhouse as a dedicated member of the Board of Trustees, but she is also a founding member of the Leading Ladies program. She has since led as a Leading Ladies program co-chair, served as an event co-chair, and donated her time as a steering committee member for eight seasons. Linda and Gary have been donors to the Playhouse since 1992; are members of the Playhouse's major gifts society The Artistic Director's Circle; regularly sponsor an annual production as Honorary Producers; take advantage of Red Carpet packages to introduce friends and colleagues to the Playhouse; and have made a significant commitment to the Capital Campaign. In addition to this generosity, service, and leadership, she has also been a member of the Capital Campaign Cabinet for the last three years, helping to lead the effort for a new mainstage theatre complex.

Most importantly, Linda is a member of the Morse Johnson Society, a group of people who have generously included the Playhouse in their estate planning. It is her hope that others will be inspired to make similar commitments and leave their own legacies to the theatre that they, like Linda and her family, love.

The gift was made to support the Cincinnati Playhouse in the Park so that it can continue to provide unequaled artistry and masterful live theatre experiences for generations to come.

Through Linda's foresight and generosity, she is making it possible for the Playhouse to continue to produce the highest quality live theatre experiences well into the future. Linda stated, "I was inspired to make a legacy gift to the Playhouse by my mother, who loved the theater, especially the Playhouse. It is that community experience that only happens with live performances, which I value. David Hoguet Nominated by Jewish Cemeteries of Greater Cincinnati (JCGC)

JCGC serves the burial needs of the Greater Cincinnati Jewish community with care and dignity and honors the resting places of our people. JCGC manages 25 Jewish Cemeteries, providing burial services in keeping with the traditions of Judaism, as well as preserving and maintaining the rich history and heritage of the cemeteries and the dearly

departed, through educational programming and through providing genealogy resources.

The breadth of David Hoguet's support and involvement with Jewish Cemeteries of Greater Cincinnati cannot be overstated. When Jewish Cemeteries was formed in 2008 to merge and collectively manage Cincinnati's Jewish cemeteries, David agreed to be the interim director for 6 months; Just under 9 years later, he retired from the position!

David transformed 24 distinct cemeteries into a consolidated, efficient operation, while still providing a caring agency for all community members. He helped mold the initial board, consisting of representatives of the various cemeteries, into a highly respected community-wide board of leaders from all currents of Judaism. While serving five different presidents and with a continually changing board, he provided steady leadership and ensured financial viability. David also was a tremendous advocate for the staff of the new organization.

David improved maintenance of our cemeteries, ensuring proper respect for all our dearly departed, and helped preserve and promote the rich history and heritage of the Jewish community. He stewarded the initiative to financial sustainability and made the new organization truly the envy of communities around the country and a model that others hope to emulate. David also oversaw the development and dedication of Cincinnati's first new Jewish cemetery in sixty years, which will meet our needs for the next century.

David deftly and passionately helped lead JCGC's Friends campaign and its first and second Legacy campaigns, through the Jewish Federation's Create Your Jewish Legacy initiative. David led by example, establishing his legacy commitment to Jewish Cemeteries, so that he could ask others to join him. Thanks not only to his administrative oversight, but also his sincere and successful legacy conversations with prospective donors, Jewish Cemeteries now has over 70 legacy commitments.

David and his wife, Karen, made a legacy gift to JCGC because they "wanted to give back to help see that the good work done in David's time at JCGC continues, and to honor and preserve the history and memories contained in our cemeteries."

Upon David's retirement as Executive Director, his deep sense of responsibility and desire to serve others led him to agree to serve in a volunteer capacity on two committees, including our Legacy Committee, as well as consult on various issues.

David does everything in a quiet, unassuming, humble manner, belaying the confidence and utter mastery of a diverse skillset, with which he tries to make the world a better

place in several other volunteer roles, as well. He recently completed terms as Talbert House Board Chair and Plum Street Historic Preservation Fund Board Chair and has devoted time to Hebrew Union College, Seven Hills School and GRAD Cincinnati.

He shies away from the public spotlight and from recognition, and works with a belief and feeling of responsibility, which he continues to exhibit in professional retirement. JCGC was incredibly fortunate to have David as an Executive Director and are equally fortunate and grateful to have him continue to stay involved in a volunteer capacity.

David's Legacy Gift will help ensure that Jewish Cemeteries of Greater Cincinnati can continue to fulfill its mission. Jewish Cemeteries will always work to ensure that David's legacy, in addition to his bequest, endures. They are grateful to be able to recognize David Hoguet as their 2021 Voices of Giving honoree.

Edmund W. Jones, MD Nominated by Bethesda Foundation

The mission of the Bethesda Foundation is to connect people with their desire to improve the quality of life for patients and families by giving caregivers the resources they need to provide best in class care.

During his more than 40-year career as a highly regarded and well-respected Cincinnati surgeon, Dr. Jones (Ted) has found time to volunteer and serve his community.

Dr. Jones attended Cincinnati Country Day School and graduated from Princeton University. He received his medical degree from the University of Cincinnati College of Medicine after an internship in Chicago and a six-year surgical residency at the University of Cincinnati.

Dr. Jones practiced surgery at Bethesda, Christ, Deaconess and Children's Hospitals. In 1970, he and his partner performed the first operation at the newly opened Bethesda North Hospital. He became a pioneer in the use of surgical stapling which was in its infancy at the time and for many years he served as a consultant and advisor to two major stapling companies.

Throughout his distinguished career at Bethesda, Dr. Jones served in many leadership roles. He was an elected officer of the medical staff for 19 years and served as Chair of the Bethesda Foundation Board and the Bethesda Inc. Board. Dr. Jones has also served

as a member of the Bethesda Governance Committee, the Development Committee, the Community Outreach Grant Committee and the Marketing Committee.

Dr. Jones currently serves as a Trustee on the Bethesda Foundation Board, the Hospice of Cincinnati Board and is Founder and Co-Chair of the Retired Physicians Senior Staff Committee. Dr. Jones is a longtime supporter of the Bethesda Foundation and became a member of the Legacy Circle when he let the Foundation know that he has included Bethesda in his estate plans.

According to Dr. Jones, "It has been an honor and a privilege to serve the Bethesda community throughout my career. By making a Legacy gift to the Foundation, I hope to ensure that the programs and services that I support now and hold dear to my heart, will be available for those who need them well into the future."

Carol A. Bowers Morton Nominated by CET

CET's mission is to strengthen the communities it serves through programs and services that inspire and inform, educate and engage, fostering citizenship and culture, the joy of learning and the power of diverse perspectives.

Life-long learning and service to others have always been a part of Carol's life. Carol thrives on learning and looks forward to CET public television's programs on history, arts, science, culture, news, current events, traveling, gardening and BBC offerings. Carol grew up in Milan, Indiana and then went on to Butler University and graduated from the College of Pharmacy, where she was an annual supporter throughout her career. For forty-two years, Carol was a practicing pharmacist who worked in retail and hospital settings and also served as a consultant for a long-term care facility. During her career, Carol obtained certifications in diabetes management, immunizations and alternative therapies accreditation.

Even with lengthy workdays, Carol found the time to volunteer for hospice as she visited and listened to patients in their final time. With Carol's love of animals, you could also

find her volunteering at the Louisville Zoo, cleaning giraffe and rhino enclosures. Throughout Carol's life, she has developed a creed of re-use, re-store, and recycle in order to make a difference. This idea extends to her historic home built in 1849, filled with beautiful antiques, and property being willed to Indiana Landmarks in a preservation covenant.

In addition to the legacy that Carol is leaving Indiana Landmarks, she will leave her retirement account to CET. Public television has received Carol's annual support for almost five decades, beginning with KET when she lived in the Louisville area. In 2011, when Carol moved to Brookville, Indiana, she became an annual supporter and friend to CET.

Since her retirement from pharmacy, Carol volunteers at her local library where they saw her talents and offered her a part-time position. Carol's work at the library inspired her to author a children's book, *Odda the Little Viking*, which was published in 2018. In addition to working part-time at the library in her community, Carol enjoys continuing to restore her historic home where she lives happily with her rescued cats. She also has enjoyed traveling the world in her retirement.

With CET as the beneficiary of Carol's retirement account, her future gift will support the important mission of making public media free and accessible to all, as it reaches millions of viewers throughout the region. Carol stated, "Above all, I want public television, CET, and what it offers to all ages, to continue beyond my lifetime. For an ordinary citizen, this is a heartfelt gift and a legacy after my years of labor."

Niehaus Law Office, LLC Nominated by St. Vincent de Paul - Cincinnati (SVDP)

St. Vincent de Paul is a network of neighbors, inspired by Gospel values, growing in holiness and building a more just world through personal relationships with and service to people in need.

Niehaus Law Office, LLC, has long supported and collaborated with SVDP and through consistent, professional planned giving assistance, they have helped their clients support the charitable missions of SVDP and many other nonprofits.

Specializing in wills, estates, and elder law, Niehaus Law serves many clients who are poised to support local charities with legacy gifts. Introductory estate planning conversations with clients include discussion not only of wills, trusts, and powers of attorney but also clients' charitable inclinations and the most tax-efficient ways to support their favorite non-profits. Attorneys Anne Niehaus and Stephen Doyle co-led a virtual session in the fall of 2020 and plan to host additional sessions in the months ahead.

Specifically, about these estate planning sessions, Anne Niehaus says, "We don't mind if Niehaus Law doesn't get any new clients from these sessions. What is most important to us is educating these friends of SVDP about estate planning in general and giving them

ideas for the ways in which they can support, through planned gifts, the essential assistance that St. Vincent de Paul provides."

One in seven neighbors in our tristate area is at risk of hunger. Freestore Foodbank's mission is to improve lives by eliminating hunger in partnership with our community, and our vision is to create a hunger-free, healthy, and thriving region. To achieve this vision, our objectives are to provide nutritious food, connection to support services and hope through a pathway from crisis to stability.

Supporting people who need help has always been part of the Reeds' lives. Once a week, Connie and Bob cook together as part of their church's work to prepare hot meals for the hungry. They also support Freestore Foodbank: Bob and Connie have been donors for more than 30 years!

Currently the Reeds contribute to Freestore Foodbank's eight-week culinary training and job placement program, Cincinnati COOKS! One culinary student particularly impressed Bob. "She was struggling and COOKS! taught her the skills to get on her feet and land a job. That kind of turnaround is what we like to support."

In the past, the Reeds also have funded Freestore Foodbank's school pantries which provide low-income middle and high school students and their families with shelf-stable food and distributions of fresh produce.

In addition to being long-time contributors, Bob and Connie recently informed Freestore Foodbank that the organization will be a beneficiary of their estate. "Our children have done well, and we have provided support to the grandchildren for their education. Part of our estate will go to the family, and a large part will benefit organizations we support, like Freestore Foodbank."

"Our point of view is that we have benefited from our society so in our estate plan, we

want to give back to our community for the good fortune we have had." The Reeds' planned gift will help the entirety of Freestore Foodbank operations. Carol J. Schroeder Nominated by Cincinnati Zoo & Botanical Garden

For nearly 150 years, the Cincinnati Zoo & Botanical Garden (CZBG) has been a community treasure, whose legacy is one of excellence in animal care that inspires visitors and supports wildlife beyond its borders. Donors and volunteers, such as Carol Schroeder, have enabled the Zoo to engage millions of children and adults through the years as the Zoo brings people "close enough to care" about wildlife and conservation.

Carol Schroeder, a native Cincinnatian, and proud graduate of Woodward High School and University of Cincinnati grew up with a love for nature and animals. "Perhaps it was the influence of Girl Scouts in my early years," she says.

She retired in 1995, from a professional career at Cincinnati Bell and AT&T in regulatory, finance and rate planning, to be a caretaker for her mother who had suffered a stroke. After her mother's passing, Carol started to explore volunteer opportunities. Culling on her love of nature, she investigated the CZBG. "I was impressed with all of the different programs that touch all generations. The Zoo is not just about plants and animals. It is about conservation and community."

Since 2016, Carol has logged over 400+ hours volunteering in such areas as CREW (THE CARL H. LINDNER JR. FAMILY CENTER FOR CONSERVATION AND RESEARCH OF ENDANGERED WILDLIFE), Animal Encounters, and Volunteer Educators. That is quite an accomplishment in less than 5 years, especially given the Zoo's closure/limited volunteer opportunities during for COVID!

Impressed with how well CZBG is run, Carol has made CZBG a beneficiary of her IRA. This generous undesignated gift will benefit the Zoo's greatest needs. "I am pleased to be able to leave a financial legacy to our wonderful zoo, an organization that promotes my personal goals of animal welfare, conservation and bringing people and wildlife closer together."

Additionally, Carol recently created a four-year renewable college scholarship for needs-based Greater Cincinnati high school students who want to major in animal-related sciences. Carol says she was inspired by The Cincinnati Zoo Academy, an affiliate of Hughes STEM High School. This academically challenging four-year college preparatory program is the only high school program in the country that pairs students with zoo professionals for daily hands-on work experience. Students take classes that prepare them for leadership roles in the fields of conservation, environmental science, and plant and animal care.

The Zoo is honored to thank and recognize Carol for her amazing bequest and extend our appreciation for her vote of confidence in our efforts to ensure a world where both wildlife and people can thrive. Her legacy will have meaningful impact on countless Zoo visitors for years to come.

Sherry Sheffield Nominated by Miami University

Miami University, a student-centered public university founded in 1809, has built its success through an unwavering commitment to liberal arts undergraduate education and the active engagement of its students in both curricular and co-curricular life.

Sherry Sheffield graduated from Miami University in 1967 with a bachelor's degree. She is a retired administrator with the Ohio Hotel and Lodging Association and spent half of her career working to grow Ohio's travel industry and the other half in the broadcasting industry. In retirement she is passionate about her work as the archivist for the Wyoming Historical Society.

What else is she passionate about? Her family, and Miami University – two things that are tied very closely together. Sherry has chosen to honor both Miami and her parents by

creating the William T. Sheffield Award of Distinction to recognize those who go above and beyond in contributing to Miami athletics and reflecting positively on the university.

"My love for Miami started with my parents," Sherry said. "My father was a man of great honor and integrity and being able to offer this award is my way of thanking Miami for the prominent part it played in his life. His award is not about achievement as much as it is about passion."

The William T. Sheffield Award of Distinction will be presented annually, if warranted, to a coach, staff member or non-student volunteer and will include a monetary award. The William T. Sheffield Student Award of Distinction will be awarded to a Miami student. Both award winners will be recognized during a Miami home football game, and their names will be included on plaques within the Walter L. Gross Family Student-Athlete Development Center.

A former president of the Miami University Alumni Association and the Cincinnati Miami Men's Club, William and his wife, Jeanette Stockmeier Sheffield '43, were regular and visible figures at Miami sporting contests, holding season tickets for football and basketball and typically wearing their trademark red and white Miami cowboy hats.

"Dad was 6-foot-4 and mom was 5-foot-11, so you could see those red hats up over the top of a crowd," Sherry recalled.

William Sheffield left Miami six months short of graduation to serve as a ground school flight instructor in World War II. Following his service, he went on to earn his law degree—which at the time did not require an undergraduate degree—from the University of Cincinnati. Though his legal career was under way, William, out of respect for the opportunities Miami had given him, as well as the guidance he had received from faculty, returned to campus as a commuter student and completed requirements for his bachelor's degree in 1949—more than a decade after he first set foot on campus.

Sheffield went on to serve as a judge and spent the rest of his life repaying his debt to Miami through dedicated service and unwavering loyalty. Sherry's gift is her way of continuing her father's gratitude.

"William T. Sheffield's story is inspiring, and the awards in his honor will be very meaningful to those we are able to recognize," said David Sayler, director of Miami's intercollegiate athletics. "Miami athletics is more than coaches and student-athletes. It is truly a family effort involving support staff, faculty and students as well as alumni and friends. We're grateful to Sherry for this important investment in celebrating those who

make Miami athletics and Miami University great."
